BACKGROUND/SUMMARY:

The City Council and Staff hosted a series of public input meetings for the Murphey Candler Lake House. The results from the public input meetings have been used to create the concept plan for the Murphey Candler Lake House Concept Plan.

The City Council and Staff sought out public input on the parking lot expansion concept plan that will be used for the Lake House and various other activities at Murphey Candler Park. Staff is recommending that Murphey Candler Park Lake House Parking Lot Concept Option #3 be considered and approved by the City Council.

The Park Bond Resolution, as passed in November 2018, includes parking lot improvement throughout Murphey Candler Park. The Murphey Candler Lake House and Murphey Candler Lake House Parking Lot Expansion Projects are included within the \$8,984,138 Estimated Total for Murphey Candler Park Master Plan.

FISCAL IMPACT: (Budgeted – over or under)

Funds for this project have been allocated within the \$8,984,138 for the Murphey Candler Park Master Plan.
